# 150991.Update on Alachua County Comprehensive Plan Evaluation and Appraisal<br/>Report Process - Regarding Urban Cluster Line (B)

Wendy Thomas gave an introduction.

Lila Stewart and Rick Hutton made presentations.

Motion by Commissioner Warren, seconded by Commissioner Johnson: Staff prepare information for consideration on waiving fees in support of affordable housing that reduce cost of home without increasing costs to developer. Motion passed 6-0. Commissioner Arreola absent. Motion by Mayor-Commissioner Pro Tem Hayes-Santos, seconded by Commissioner Warren: 1) refer to a future GPC discussion, the drafting of an ordinance to adopt a water/wastewater service area map; 2) reach out to the County to work with City staff to create a short-term annexation area that is agreeable by both bodies; 3) authorize the Mayor to send a letter on behalf of the Commission and welcome back to all the new residents and property holders; and 4) do a press release on annexations. Motion passed 6-0. Commissioner Arreola absent.

**RECOMMENDATION** GPC hear a brief presentation and facilitate discussion.

#### **<u>180044.</u> Dance Alive Presentation (NB)**

Gary Ascani made a presentation and introduced the current dancers.

Motion by Mayor-Commissioner Pro Tem Hayes-Santos, seconded by Commissioner Warren: 1) direct staff to bring back a general art and funding increment for the 2019 budget and to also look at the CAFI allocations that haven't been changed in 20 years; 2) direct staff to explore opportunities for Dance Alive and come back to the City Commission; and 3) refer the Arts in Gainesville item to the GPC. Motion passed 7-0.

Listed below are comments/suggestions from the City Commission:

Commissioner Ward: 1) increasing cultural arts funding; and 2) performance space across from the Cade Museum.

Mayor-Commissioner Pro Tem Hayes-Santos: 1) supports increasing cultural arts funding; 2) expanding working with other cultural partners; and 3) need of a community-arts and music-cultural space.

Commissioner Simmons: 1) supports more funding; and 2) staff to work with Dance Alive to become more involved in community-outreach, particularly in the under-deserved areas (community centers, after school).

Commissioner Warren: 1) supports funds to be increased; and 2) RTS center facility.

Commissioner Arreola: 1) supports funding; 2) great having this discussion at the Commission level (be cognizant and most fair to everyone); and 3) create our own national center for arts and technology.

Commissioner Johnson: 1) have a space dedicated to all of the arts; 2) making the process transparent and criteria set; and 3) whomever we partner within the City, they are familiar with our diversity initiatives, especially with the Equal Opportunity Office.

Mayor Poe: 1) important that whatever level and type of participation is involved, that staff discuss with Dance Alive; 2) public/private partnership (commitment/goals) and understanding what the commitment is to outreach and work within the community; and 3) funding revenue questions, criteria for eligibility and facility discussion.

Dan Hoffman and Fred Murry spoke to the matter.
