Summary of Group Priorities:

Group #1 (Commissioner Simmons) Many communities don't have an identity. For example - Porters is surrounded by many districts, but neighborhoods go unnoticed surrounded by major corridors. Create connectivity through neighborhoods, signage, entry/exits, with historical signage. Wayfinding signs would add to quality of life - i.e. Welcome to Duval, etc. Critical Home Repair Program - Layers of health/safety, reduce slum/blight. Use folks in workplace training within their own neighborhoods. Ambassador Program - Within CRA to mentor and incentivize entrepreneurship. Partner with the University of Florida and School of Business. Equity, quality of life, unemployment rate. Pop Up Stores - In empty locations downtown. Stop incentivizing - large development and managing property. Tailor a program for small business with employees.

Group #2 (Mayor-Commissioner Pro Tem Hayes-Santos) "Reimagine Programs" -

long-term sustainability of commercial districts - create Business Improvement District. Connect multi-modal areas/public spaces and revitalize. Share funds across all needed areas. Incentive Programs - rate to go after highest need. Economic Development - help build companies and keep growing companies here.

Group #3 (Mayor Poe) - Façade grants aren't transformational in terms of development. Stormwater problems - could this be creatively solved with creating of infinity loop. Affordable housing - top three priorities. All parts of organizations must play a role. See how the CRA can serve as the "Connective tissue" - Rebuilding Together, CWC, Habitat for Humanity, Gainesville Housing Authority, together, GRU. Business Improvement District - get all businesses to take ownership of the outcome private/public.

Group #4 (Commissioner Arreola) - Affordable housing and policy changes to require those demolishing homes to replace with certain amount of affordable housing. Inclusionary zoning, destination projects, create specific designs for education/after school programs. Focus on the needs of the community. Activate "dead zones" - be it commercial/dead zones, activate for nonprofits. Public/private partnerships. Complete streets upgrading amenities on main corridors.

Group # 5 (Commissioner Johnson) - Redirect funds/resources to help affordable housing and a community food center, clinic, etc., especially on the eastside. Safety adequate lighting, streetscaping. Public/private partnerships. Funding/financing - do it better. Regulated community engagement - do the work to get the real engagement needed in the community. Steps - use the least amount of money for the most good. Don't displace people already there in the neighborhoods.

Group # 6 (Commissioner Warren) - Good food, i.e. grocery stores in Eastside. Incentivize downtown locations to rent to small businesses. More residential support for homeowners/tenants - paint projects, paint the town, etc. Expand boundaries for CRA districts - 6th Street, Koppers, Grove Street area. Partners: CareerSource, GRU, Project Youthbuild, Santa Fe College, School Board and University of Florida.

Group #7 – Workplace Training (Ed Bielarski) – Power Academy, Workplace Training Institute, Co-housing-workforce housing. Rehabbing homes as a workforce especially in 1200-1500 square-foot cinder block homes. CCC Programs for example. Partnerships for targeted industries at entry level - with Chamber of Commerce/Santa Fe College. No stops on current resources.
