#### 180211. General Fund Transfer Resolution Discussion (B)

Ed Bielarski gave opening remarks.

Mark Benton made a presentation.

Tom Brown, Diane Wilson, Carlos Holt, Mary Alford, Jesus Gomez, Fred Murry and Dan Hoffman all spoke to the matter.

Diane Wilson – spoke to General Government vacancies and need for direction regarding General Fund Transfer (GFT) so General Government can make adjustments and prepare financials for budget season accordingly with cuts as directed. GRU is service oriented, General Government is more people intensive, so cuts would definitely affect staffing levels. Currently GFT reduction amounts as mentioned between 10-13 million is approximate 10% of General Government's budget.

Commission would like to see additional analysis brought back to address deficit to include but not limited to:

- · Refinancing current GRU debt
- · Closing GRU lobby services
- · Gas prepayment options
- Wholesale contracts what's the potential for these?
- Plan for onboarding Deerhaven Renewable employees
- · Additional info around UPIF brackets and any flexibility available
- · Overview of wholesale market
- Bring back rate (GRU) movement v. millage movement, side by side comparison with a focus on homesteaders (homeowners v. renters)
- · Interested in any other nontraditional alternatives to reduce budgets
- Service level reductions and consolidated utility personnel moves to EOC and/or

co-located GG/GRU functions, i.e. customer service call center

- Hiring Freeze
- · Charging for mailed bills
- SAS Model
- Potentials of adding/offer GRU renewable services to UF and what projected income would look like
- · How electric busses could decrease annual fuel expenses
