Commissioner Ward: 1) Agrees with "straws by request" ordinance. Likes what St. Pete has done; and 2) City Commission meetings are the venue to discuss new ideas and it's ok to disagree but doesn't have to be contentious. "We are neighbors - don't be angry, come talk to us".

Commissioner Johnson: 1) Email received - "time sensitive" - grant available for 18-month program (help a selective group of cities chart a path to inclusive growth due to lack of affordability - 2 to 1 matching grant - deadline is February 28, 2019. Will put this on the next GPC agenda for a short discussion.

Commissioner Simmons: Wants motion on screen at future meetings.

Commissioner Warren: 1) Prison labor contract - push for legislative lobbyist to take up prison reform for more education, training, etc.; and 2) Staff to report to Commissioner Warren on a update on building renovations.

Mayor-Commissioner Pro Tem Hayes-Santos: Agrees with Commissioner Simmons.

Mayor Poe: 1) County Commission considering terminating funding for GRACE. Staff to ask Jon DeCarmine/representative to prepare for what the \$750,000 cut would look like for their budget at a joint City/County meeting; and 2) Charter's to train/certification - citizen advisory boards on city policy re: harrassment, etc. Wants plan to address.

Mayor-Commissioner Pro Tem Hayes-Santos: Staff to get an analysis about what the County said about GRACE and CRA.

Motion by Commissioner Arreola, seconded by Mayor Commissioner Pro-Tem Hayes Santos: City to have lobbyists begin to oppose the County's anticipated CRA bill. Motion passed 7-0.

Mayor Commissioner Pro Tem Hayes-Santos: Wants a follow-up on board ethics discussion - re: finances.
