DISCUSSION OF PENDING REFERRALS

180260. UF and City Partnership Update (B)

This is a request for the City Commission to hear an update on the UF-City Partnership framework being developed and approve staff to pilot the framework using the Food Policy Council initiative.

Motion: Direct staff to come up with a framework for the UF-City partnership framework; and to pilot the food policy initiative.

Commissioner Warren arrived at 1:06 PM.

Roberta Griffith, Director of Strategic Initiatives, gave opening remarks.

Dr. Charlie Lane from the University of Florida, will call into the meeting.

Assistant City Manager Dan Hoffman made an announcement regarding a \$2 million grant from the National Science Foundation to study traffic and transportation improvements.

Commissioner Simmons arrived at 1:06 PM.

Mayor-Commissioner Pro Tem Hayes-Santos thanked staff and UF.

Commissioner Warren asked about UF involvement. Dan Hoffman responded.

Commissioner Ward asked about the grant application process and award. Dan Hoffman responded.

Dr. Charlie Lane introduced the presentation: "Increasing Meaningful Impact in the Gainesville Community: Enhancing and Structuring the Partnership Between the City of Gainesville and the University of Florida".

Roberta Griffith gave an overview of the presentation on the UF-City partnership.

Commissioner Warren asked if a timeline has been identified. Roberta Griffith responded that a potential pilot project will be presented.

Andrew Dais, University of Florida Director of Collaborative Initiatives presented about the role of the University and potential influence across the community.

Commissioner Simmons commented about the potential partnership. Andrew Dais responded. Commissioner Simmons expressed concerns about the partnership process communicated in the presentation. Andrew Dais responded.

Mayor-Commissioner Pro Tem Hayes-Santos commented. Interim Assistant City Manager Bowie responded. Commissioner Ward responded.

Commissioner Johnson commented about the request for a food policy council coming from the community on the east side of Gainesville. Suggested that the part of calling for project/activity proposals should not leave out groups or organizations that do not have the capacity to respond; should offer assistance and consider how to include grassroots organizations.

Commissioner Ward commented about food insecurity affecting people all over Gainesville.

Commissioner Arreola commented about the importance of research and development by institutions, but does not want the partnership to solely be about research and development. Asked about how City and UF can make unified strategic decisions.

Commissioner Johnson clarified her comment about the food policy council.

Commissioner Warren commented in support of moving forward with the conversation. Spoke against focus on measurability in a short time period; will need a long-term commitment. Roberta Griffith responded. Mayor-Commissioner Pro Tem Hayes-Santos spoke to the issue of measurable outcomes.

Deborah Bowie continued the presentation, discussed next steps.

Mayor-Commissioner Pro Tem Hayes-Santos spoke in favor of moving forward with the partnership, using the food policy council as a pilot collaboration. Asked about next steps.

Roberta Griffith commented that staff will bring back an update on the food policy council, probably in the next three months.

Commissioner Ward asked if staff needs direction on recommendations for partnership framework. Deborah Bowie responded in favor of a motion from the Commission.
