Ms. Demetropoulos, PRCA Nature Manager, discussed the Hartman House renovation project at Hogtown Creek Headwaters Park which has a \$400,000 budget. At 80% of the 1% for public art this will provide \$3,200 for public art commission. Leslie Tharp's previous commissions at the Park were reviewed, as well as images of the restroom facility and the past use of the park (as a dairy farm). Ms. Demetropoulos, Ms. Wazny and Mr. Etling will meet with Leslie Tharp to discuss the budget

and ask for a proposal.

**STAFF REPORT**

Mr. Etling reviewed the previously funded 352walls projects that have yet to be completed and the balance in those allocations and the balance of unassigned funds. It was discussed that \$10,000 of the unspent funds previously dedicated to 352walls possibly be applied to the Shephard Fairey mural project and the \$5,000 APPT funds dedicated to the Firewall be used if Mr. Fairey paints a mural on that wall.

Mr. Etling next discussed the idea of painting a bold abstract mural in the two ponds in front of City Hall before they are refilled. Staff is reaching out to the University of Florida School of Art and Art History as a possible project for them. Al Maser was discussed as a potential artist. The Trust was interested in receiving a proposal for funding with more information about the potential artist. The Trust agreed to receive a request between meetings for review and possible approval.
