#### **Septic Tank Discussion:**

1) Stacie Greco and Shane Williams, ACEPD, presented responses to the 3 questions asked in previous meetings: (1) Work with local septic tank installers to get real costs about retrofitting systems/implementing ordinance; (2)The County being the supplier of the materials for the denitrification layer; and (3)They provided an estimate of about 25-30% existing septic systems in County

would require aerobic instead of in-ground nitrogen reducing biofilter (INRB) due to depth to groundwater limitations. Next steps - ACEPD will continue to monitor Poe Springs retrofit, will await the court decision on the BMAP challenge, and will request FDEP extend retrofit rebated funds to Alachua County. ACEPD is hopeful to come back to JWPC with a presentation on progress of next steps in late summer/fall. The hope is for more data to be available before an ordinance requiring all new systems have an INRB.

2) Rick Hutton, GRU, provided an overview of the Fox Grove/Featherwood septic to sewer alternatives. He explained option types including gravity, low pressure, or a combination of the two. Additional information included estimated costs and discussion of septic to sewer conversions using the ConnectFree program. Residents of Fox Grove & Featherwood are considering options and GRU is formulating policies for low pressure sewer systems. There will be an update on ConnectFree to the City Commission soon. Additionally GRU requested cost share grant funding from the St. Johns River Water Management District to help pay for sewer connections for ConnectFree applicants near creeks. City Attorney Nicolle Shalley answered Commissioner Hayes-Santos regarding guidelines surrounding mandate for sewer connection.

#### Redefining the Role of JWPC to include Climate Change:

1) Steve Hofstetter, ACEPD, came with direction from the joint City/County Commission meeting on Feb.3rd to clarify future involvement of JWPC with regard to climate change. Issues discussed included name change, role of JWPC in selection committee and overall scope of involvement.

#### **Stormwater Assessments:**

- 1) Shane Williams, ACEPD, said the County's assessment is non ad valorem and is set at \$40/ERU. Most residential properties pay on a tiered structure. Assessment is split 50/50 between water quality and drainage system maintenance. Some current projects benefitting from the assessment were discussed.
- 2) Sally Adkins, Gainesville Clean Water Partnership, spoke about the City's stormwater assessment billing, services, and programs.

#### MEMBER COMMENT

Motions referred to respective commissions and approved:

- 1) Refer to County Commission a request to consider adopting a policy wherein County owned and maintained septic tank systems at time of replacement be of the INRB type to establish a baseline research plan and to consider the formation of a residential experimental model wherein the County subsidizes the system to monitor results
- 2) For the sole item on the April 20th JWPC agenda be for County and City staff to make presentations on what their respective entities have done and are currently doing to address the issues of climate change
