The PRC discussed the 2020 Pension Obligation Bond proceeds investment allocation schedule that had previously been adopted. Although the S&P 500 Index had come down near the 5% trigger point for accelerating future investment allocations, PRC members agreed that it made sense to wait until after the November 3rd elections to consider making any investment allocations. There was also concern about

TWIN's under performance, and the Plan's fixed income asset allocation. The PRC indicated interest in considering a shorter duration fixed income investment allocation through Loomis Sayles. Also, the targeted fixed income allocation was determined using the Plan's expected net annual cash requirements for benefit payments that may need to be withdrawn from the Plan's investment accounts in September 2021. TWIN and Loomis Sayles will be attending the December PRC meeting, and can discuss the Committee's concerns.
