Discussion Regarding the Investment of the City's 2020 Pension Obligation Bond Proceeds (B)

After lengthy discussions, the Committee approved recommending the 2020 POB Proceeds Investment Schedule Proposal that was outlined in the AndCo Memo dated October 20, 2020. The Memo specifies investment manager allocations of \$60,000,000 to be made the week of November 9th, 2020. Additional investment manager allocations of \$60,000,000 and \$56,000,000 will be targeted for the end of December 2020, and the later part of January 2021 respectively, with specific details to be determined by current market conditions at those times, and accelerated investment allocation allowed in the event of market declines.
