#### **BUSINESS DISCUSSION ITEMS**

**<u>200650.</u>** Neighborhood Workshop Continuation Special Meeting (B)

Motion by Mayor-Commissioner Pro Tem Johnson, seconded by Commissioner Arreola:

(Part 1) Accept proposed neighborhood notification process, including email notifications for neighborhood workshops to be sent to neighbors affected by the process (individuals belonging to neighborhood associations and others who voluntarily sign up to receive emails). Ask staff to research best practices from other communities about thresholds for intermediate and major development. Motion passed unanimously.

(Part 2) Direct staff to bring back an ordinance asking that all intermediate and major development review come to the Development Review Board for final approval. Motion passed 4-3. Mayor Poe, Commissioner Hayes-Santos and Commissioner Saco in dissent.

Motion by Commissioner Hayes-Santos, seconded by Commissioner Saco:

(Part 1): Have the policy passed tonight reviewed by Office of Equity and Inclusion as part of the Equity Toolkit. Motion passed unanimously.

(Part 2) Planning staff to analyze how the passed policy will impact housing costs. Staff analyze any new costs the City will incur from passing this policy. Staff analyze what is the extra length of time to create new housing. Motion passed 6-1. Mayor-Commissioner Pro Tem Johnson in dissent.
