Robert Klemans will serve as the representative from GRU. During the August JWCPB meeting the Board will have to select three new members for the CCAC.

There were discussions about the need for further discussions about solar in our community and equity with GRU, Duke Power, Clay electric, and citizen groups present. This is tentatively planned for the October 25, 2021 meeting.

Board members requested a future discussion about next steps for water conservation and policies that the respective commissions can pursue.

The Board will need to elect three new citizens to the Citizen Climate Advisory Committee at the August meeting. A portion of the meeting will be allocated to

working on a work plan and goals for the following year. The meeting will continue the discussion about water conservation and should include a brief presentation from the Suwannee River Water Management District on MFLs. A representative that can discuss the role of permitting and limiting consumptive use permits and the concept of limiting irrigation wells will be invited. Staff should be prepared to discuss strategies for strengthening water conservation efforts. It was requested that Bob Knight from the Florida Springs Institute be invited to the meeting.
