<u>Petition DB-21-118 SPA:</u> Mr. Stuart Cullen, agent for Fiber Swimming Pools Dist., Requesting authorization to allow outdoor accessary storage and Display up to 25% of the existing indoor storage area. Zoned: BA (Business Automotive) Located at 4322 NW 13th. Street.

**<u>RECOMMENDATION</u>** Staff recommends approval of Petition DB-21-118 SPA with conditions.

Deny the petition on the basis on the lack of a development plan, that storage is not allowed, that the proposed outdoor storage is incompatible with the area and the applicant has not adequately addressed the requirements of the code to utilize
