200744. Candidate Qualifying (NB)

Motion: Ask staff to bring back changes to qualifying in which candidates may (1) collect signature petitions from 1% of the registered electors in the district in which they are running, with the caveat that during a redistricting period, the signatures can be taken from anywhere in the City; including a charge of \$.10 for each petition with the City subsidizing \$.20; (2) pay a qualifying fee of 2% of the office's salary instead of petitions. Bring back to the Commission in January.

- (2) Qualifying fee: Motion passed 4-1 Mayor-Commissioner Pro Tem Arreola in dissent, Commissioner Duncan-Walker absent.
