PRCA Staff Report

Morningside Cane Boil/Fiddle Fest is Saturday, 11/27, 10am-3pm Hardwood removal project is taking place at Boulware to reduce off-site hardwoods for restoration.

Nature Operations Supervisor is scheduled to start work. He will attend an NCC meeting when settled in.

Loblolly boardwalk repair is underway and making good progress.

There is a new program "Citizen Science for kids" at Headwaters Nature Park, Nov. 21st on spiders. 1st program in new building.

Gainesville Greenway Challenge (to address invasive plants); volunteers from Trilogy School pulled tuberous sword fern at Ring Park. Habitat Naturalist is working on Ring wildflower garden project with a volunteer who is working with Wendy Wilber.

FWC has an Upland Invasive Exotic Plant Management Program. Nature Operations applies to this program annually for invasive plant treatment. There is a current contract for Ardisia treatment at Colclough Pond Nature Park.

Committee Report

a. Policy Committee

Michael reported on discussion from virtual Policy Committee meeting that took place on 11/4/2021 regarding Imaging GNV, Gainesville's proposed Comprehensive Plan. Linda had previously sent a link to members with the current City Comprehensive plan. Linda stated she was worried that grant applications (such as Florda Communities Trust) that required a local government to meet certain Comprehensive Plan requirements would be jeopardized. Linda suggested that the city could revise current plan or include the equity plan (Imagine GNV) as an addendum.

Mike proposed to draft a letter to City Commission from NCC with combined comments.

Jesse observed that the draft Imagine GNV does not address land use like Comprehensive Plans typically do. It also appears to address the built environment but should really focus on the natural environment. Jesse wondered if other elements are as drastically different as "Our Environment"

Bruce thinks that letter should state that Imagine GNV jeopardizes Florida Forever grant.

Leslie suggested that the letter reflect a unified message. The City should maintain the current Comp Plan and integrate Imagine GNV into it in order to maintain the structure.

Karen Noted that all of the recommended surveys will be expensive. Karen wants to see this element promote Community Gardens and edible landscape. Karen wants to see heritage trees protected, planting more trees, and landscaping throughout the city.

Jon recommended that the NCC board's assignment should be to review the existing Comprehensive Plan (Conservation Element & Recreation Elements) and compare it to Imagine GNV. He said that inequities need to be addressed. Could Imagine GNV be an addendum to the Comp Plan? This chapter needs to focus on environmental land use. There needs to be a community education element regarding nature for people in undeserved communities. Jon thinks Outcome 3 is appropriate.

Things Michael would like to include in a letter: Draft should be addendum to previous plan "Our Environment" should focus on environmental land use, water quality, air quality, and other things to do with

environmental health.

Would like to see more concrete numbers.

Education element for nature in undeserved communities

The board should read the current Comprehensive Plan before writing the letter.

The board should have a Policy Committee meeting again to discuss before the December meeting. Date TBA.

The City is taking public comments anytime through January and will hold a public workshop on January 26th (moved from 11/21)
