Kali Blount- saw recent Public Service Announcements regarding lock vehicles

Chief Scott: discussed further about conveyance burglaries and youth stealing guns from unlocked vehicles

Shelia Payne: Trespass after warned-this will probably be discussed during the closed IA session, resisting arrest without violence looking for numbers on how these charges on added to other charges; marijuana felony; sworn complaints sent to State Attorney Office; Gainesville Pre Arrest Program what does that mean?

Chief Scott- these are the top 10 charges for these numbers; arrests for cannabis has reduced significantly; if you are selling, then you will be arrested. Gainesville Pre Arrest is something that is referred to the State Attorney's office for the program to where there is no arrest record and this is diversion program without an arrest record

Duncan Purves- resisting arrest without violence will this be added into all these numbers

Chief Scott: will have to check into this and will bring back to the council Duncan Purves- look over a comparison over the past 10 years regarding arrests and sworn complaints

chief Scott: will pull up this information for the council. Take into factors economic issues, staffing at the time

Chief Scott: staffing we are holding. We have current applicants with

certifications and re instituted the Chief Panel which includes himself, Assistant Chief, and Chief Inspector to speak with the potential candidate before going to background.
