Ordinance No. 0-06-70  
An ordinance of the City of Gainesville amending section 14.5-26(a) of the Gainesville Code of Ordinances relating to trespass towing; providing for pro-rated administrative fees; providing requirements for pro-rated administrative fees; amending the Police section of Appendix A, Schedule of Fees, Rates and Charges by delineating pro-rated fee categories; providing directions to the codifier; providing a severability clause; providing a repealing clause and providing an immediate effective date.  
The City Commission adopt the proposed ordinance.

The City Commission adopt the proposed ordinance.

On July 10, 2006, the City Commission authorized the City Attorney to draft, and the Clerk of the Commission to advertise an amendment to section 14.5-26(a).

On May 8, 2006, the City Commission referred the issue of the Public Safety Committee to develop a proposal for

restructuring administrative fees as it applies to one community or property in contiguous locations to each other. The Public Safety Committee recommends a pro-rated sliding fee where all properties are included in one contract and are within close proximity of each other. Properties meeting these criteria would be eligible for the sliding fee scale.
