The City Commission adopt the proposed Resolution.

The City Commission, at its July 17, 2014 Regular Meeting, directed the City Attorney to prepare an amendment to the Rules of the City Commission creating a standing "Legislative and Organizational Policy

Committee" and a standing committee comprised of the entire City Commission which is referred to in this Resolution as the Standing "General Policy Committee."
