BUILDING CODE AMENDMENTS (B)

Ordinance No. 0-02-04

An ordinance of the City of Gainesville, Florida, amending Chapter 6 of the Code of Ordinances of the City of Gainesville relating to Buildings and Building Regulations; adopting the Administration Chapter of the 2001 Florida Building Code, with amendments thereto, including adoption of a wind speed line; repealing other technical codes and redundant provisions; providing directions to the codifier; providing a severability clause; providing a repealing clause; providing for penalties; and providing an effective date.

The City Commission adopt the proposed ordinance.

At its meeting of November 26, 2001, the City Commission approved the City Manager's recommendation to authorize the City Attorney to prepare and the Clerk of the Commission to advertise an ordinance: (1) adopting an amended version of the Administration Chapter of the Florida Building Code for use in enforcing the Florida Building Code and 2) amending Chapter 6 of the Code of Ordinances to establish I-75 as the dividing line for 100 MPH and 110 MPH structural wind calculations (the "wind speed line"). The attached ordinance accomplishes this.
