bounded on the west by the western boundary of Interstate 75 and the City limits, and bounded on the north by the City limits; canceling the referendum for the annexation; providing directions to the City Manager; providing a severability clause; providing a repealing clause; and providing an immediate

effective date.

REPEAL OF ORDINANCE NO. 020789 (SW 20th AVENUE, ANNEXATION) (B)

Ordinance No. 0-03-23

An ordinance of the City of Gainesville, Florida, repealing Ordinance No. 020789, which annexed a portion of the City of Gainesville Reserve Area generally described as follows: bounded on the south by the northern boundary of SW 24th Avenue as extended west to the western boundary of Interstate 75, bounded on the east by the City limits and the eastern boundary of Southwest 34th Street, bounded on the west by the western boundary of Interstate 75 and the City limits, and bounded on the north by the City limits; canceling the referendum for the annexation; providing directions to the City Manager; providing a severability clause; providing a repealing clause; and providing an immediate effective date.

The City Commission adopt the proposed ordinance.

At its meeting on February 10, 2003, the City Commission authorized the City Attorney to prepare and the Clerk of the Commission to advertise an ordinance repealing Ordinance No. 020789, which annexed the area described in the attached ordinance, subject to a referendum election that was scheduled for April 29, 2003. The second reading of the ordinance will be held at a special meeting.
