The City Commission authorize the Mayor and Clerk of the Commission to execute the Final Administrative Order.

The City Commission, at its meeting of December 2, 2010, announced its oral order regarding an appeal of a decision of the Board of Adjustment under Administrative Review filed by Pressman and Associates, Inc., agent for Main and Waldo Investments LLC., Petition No. BA-10-6 APP (Legistar No. 100547).
