The City commission adopt the proposed ordinance, as amended.

At its meeting of August 9, 1999, the City Commission authorized the City Attorney to draft and the Clerk of the

Commission to advertise an ordinance amending the franchise term of the ordinance to expire September 30, 2004, adding service level provisions, adding construction and demolition disposal tracking, and adding recycling goals and service quality provisions aimed at the franchise holders.

At first reading, changes were made as recommended by the City's Solid Waste Manager, Stephen Hiney. A new subparagraph (h) has been added per the direction of the City Commission.
