**Title:** OUTDOOR LIGHTING REGULATIONS (B) Ordinance No. 0-01-34, Petition No. 147TCH-00PB An ordinance of the City of Gainesville, Florida, relating to outdoor lighting; Providing for Intent and Purpose; amending Section 30-23(c) of the Land Development Code by adding definitions; amending Subsection 30-160(d)(33) of the Land Development Code to require a photometric plan be included as part of a preliminary development plan; amending Subsection 30-330(a)(4) of the Land Development Code setting requirements for lighting of off-street parking facilities; amending Section 30-345 of the Land Development Code setting general performance standards on lighting; creating and adding subsection 30-93(e) to the Land Development Code establishing lighting requirements for gasoline and alternative fuel service stations; creating and adding Section 30-345.1 to the Land Development Code, providing for nonconforming luminaires and a schedule for compliance; providing directions to the codifier; providing a severability clause; providing a repealing clause; and providing an immediate effective date.
